# Stanley Bridge Marina Rules and Regulations

These rules and regulations are intended to ensure the safe & enjoyable use of the marina by all tenants, boaters, and visitors. Non-compliance with these rules and regulations may result in termination of privileges or fines without refund of any fees. Stanley Bridge Marina (SBM) may amend these rules and regulations, as they deem necessary. (Revision Jan. 2021)



1. All boats shall be clearly marked with registered names and/or license numbers, as required by law. All boats shall remain in safe and seaworthy condition. SBM, at their sole direction, may request or facilitate changes or removal, at the owners expense and without abatement of required fees. SBM shall always maintain the right to board or move boats, or to reassign slips, or to utilize empty rented slips on a reasonable basis.
2. Locks and fencing are provided only for deterrence and SBM shall have no responsibility nor liability for losses, damage to, or theft of, boats or possessions in the Marina or Harbour areas.
3. Slips, docks, walkways, and access are provided on an annual basis and are to be kept free and tidy of debris (disposed of in proper containers), stored materials, hoses, electrical cords and stores. Water is provided and hoses shall be in good quality working order with no leaks.
4. Oils, contaminants, dirty water, nor debris shall not be discharged or left in the Marina.
5. Marina operations are generally from May long weekend through Thanksgiving each year. Quiet time on any day is between 11:00 PM and 7:00 AM. Clubhouse, Showers, and Laundry facilities are for Boater tenants and their guests only – while tenants/lessees are on site.
6. Overnight parking requires approval from SBM Manager and all Boater car and trailer parking shall be in the upper parking area only and not in the lower Commercial Only areas.
7. Lessees/Tenants may not sublet nor allow unregistered boats to use slips and shall advise SBM Manager of any changes in their address, phone numbers, registration, insurance details, or emergency contacts.
8. Generally, all boaters may use slips and boats, including overnight, provided that all overnight use of the Marina receives written approval of SBM, such approval may be withheld at SBM's sole and unrestricted discretion.
9. Pets are permitted on a leash - no disturbance of any kind shall be permitted. Children are to remain supervised and SBM assumes no responsibility for children or pets in the Marina.
10. Only SBM designated personnel shall complete alterations or repairs to slips or marina assets. Tenants or boaters may not affect any changes to the slip or Marina without consent of SBM Marina Manager. Unauthorized changes may be restored at the tenant's/lessee's expense. Extensive repairs made to owner boats require approval from SBM Manager.
11. Boat owners/Tenants/Lessees shall respect all **Rules of the Marina and of the Harbour Water Areas** and shall remain responsible for costs of any damage or repairs by themselves, guests, or invitees, and shall pay all fees or fines by requested dates.
12. Fines of \$25 per occurrence may be levied where rules are not followed, where payments are late, or for disturbance, lack of cleanliness, excessive noise, unsafe conditions, or nuisance that extends beyond requests for compliance. Be considerate of others and of the assets in the Marina. SBM may terminate privileges at any time and at their sole discretion.
